**BACKGROUND CHECK FORM**

I understand that in connection with my application for employment, volunteer work, and /or for continuous employment, and /or volunteer work Donald W. I understand that Donald W. Reynolds Boys & Girls Club may rely on any part or all of this Information in determining whether to extend an offer of employment/ volunteers' duties to me. I further understand that if any adverse action is taken by, or if Donald W. Reynolds Boys & Girls Club chooses not to extend an offer of employment/duties to me based upon the Information, that I will be provided a copy of such Information along with a summary of my rights under the Fair Credit Reporting Act.

I understand that the background check, which may be performed by Investigators, is being performed as part of the process to evaluate me prior to employment/volunteer and is not conducted for any purpose other than in connection with my application for employment and/or my eligibility for continued employment/ volunteer duties.

I have read this Pre-Employment and Continued Employment/Volunteer Disclosure and by signing below, hereby authorize Investigators to conduct a background check as described herein in conjunction with my application for employment/ volunteer duties. I hereby release any and all Investigators, including Donald W. Reynolds Boys & Girls Club, from any and all liability related to the procurement or disclosure of any information provided by me or obtained about me in connection with my application with Donald W. I further direct and authorize Investigators to conduct the background check and further authorize any third parties who may be the custodians of or in possession of the requested Information, to disclose such Information to Investigators in connection with this background check.
